## **12 New Cases – 616 Cases Total in Livingston County**

Livingston County, IL – Twelve more residents of Livingston County have tested positive for COVID-19 (coronavirus disease). Livingston County Health Department (LCHD) officials were notified of the new COVID-19 cases on October 21, 2020 in accordance with state and local public health protocol. The newly confirmed cases include a female under the age of 10; a male and female under the age of 10; a male in his 20s; a female in her 30s; a female in her 40s; three males and two females in their 60s; and a female in her 80s, all of whom are recovering in isolation.

LCHD officials continue to work closely with the Illinois Department of Public Health (IDPH), and have investigated and notified any individuals who may have had exposure to these individuals who tested positive for COVID-19.

As of October 21, 2020, the LCHD has received 16,339 COVID-19 test results. Of that, 616 COVID-19 tests have been positive, 15,723 tests were negative, 525 of the previously reported cases have been removed from isolation, 81 cases remain active, four cases are currently hospitalized, and, sadly, ten cases have resulted in death due to complications related to COVID-19. Of those individuals who have tested positive, 47 were asymptomatic at the time of testing. Individuals who travel to hot spots in the country, those areas where higher rates of confirmed COVID-19 cases are reported, are strongly encouraged to get tested for COVID-19 5-7 days after returning from their trip or sooner if experiencing symptoms. People can track confirmed COVID-19 cases in Illinois by county and zip code by visiting IDPH's COVID-19 statistics site: <https://www.dph.illinois.gov/covid19/covid19-statistics>, and may also track confirmed cases nationwide by using CDC's COVID-19 tracker tool: <https://www.cdc.gov/covid-data-tracker/#cases>. Drive-thru COVID-19 testing is available weekdays from 8:30 a.m. to 12:00 p.m. in the parking lot of OSF Saint James – John W. Albrecht Medical Center, located along Illinois Route 116 just west of Interstate 55. All testing is at no charge to the client. Insurance is not required to be tested; however, if you have insurance, please bring your card to your testing appointment. Persons with an appointment will receive priority service as daily testing capacity is limited. Call the LCHD at (815) 844-7174 ext. 210 or ext. 216 to schedule an appointment. For those Livingston County residents who test positive for COVID-19, the LCHD will reach out to them individually and all of their close contacts (anyone the confirmed case has been within 6 feet of for at least 10-15 minutes in the 48 prior to either experiencing symptoms or receiving testing) within 24 hours of receiving notification.

The health and safety of Livingston County residents remains the highest priority for Livingston County health officials. All partners and organizations involved in the COVID-19 response remain fully prepared to respond to COVID-19 cases. Public health, hospital systems, and first

responders maintain highly trained infection control teams, specialized equipment, and protocols consistent with the latest guidance from the Centers for Disease Control and Prevention (CDC).

Assume COVID-19 is in every community. Because people can be carriers of the virus prior to experiencing symptoms, everyone should be presumed to be carriers of the COVID-19 virus. Community members are strongly encouraged to adhere to all of the required precautions necessary to protect their families and the community by slowing the spread of the COVID-19 virus, including wearing a mask and staying at least 6' from others when in public, as well as frequently washing hands and sanitizing regularly touched surfaces.
