HOW DO I PREPARE FOR MY WELLNESS CLINIC APPOINTMENT?

1. Call the LCHD at 815-844-7174 ext 210 Monday through Friday 8:00am to 4:30pm to schedule an appointment
- Wellness clinics are held on the first and third Wednesday of every month
1. **DO NOT EAT or DRINK anything**, other than water, for at least 8 hours (preferably 12 hours) before your appointment
2. Drink **LOTS of WATER** during the 8 hours before your appointment
3. **DRINK** at least 2 to 3 glasses of water the morning of your appointment
4. You may take medication (with water), if necessary, the morning of your appointment
5. Wear clothing that will allow the nurse access to your arms for a blood pressure check and blood draw
6. Arrive 10 minutes before your appointment to complete paperwork
7. Please allow 30 minutes for your appointment

BLOOD PRESSURE CHECK

BLOOD TEST - INCLUDES: BLOOD COUNT; LIPID PANEL (GOOD/BAD CHOLESTEROL AND TRIGLYCERIDES); GLUCOSE (FOR DIABETES); AND OTHER TESTS THAT MAY INDICATE LIVER OR KIDNEY FUNCTION PROBLEMS

ADDITIONAL SCREENINGS

PSA (PROSTATE) FOR MEN \$25.00

TSH (THYROID) \$25.00

HEMOGLOBIN A1C (DIABETES) \$30.00

OSTEO (BONE DENSITY) FOR WOMEN \$20.00
